Quarterly Report October to December 2017

Executive summary

In the 4th quarter of 2017 a total of 65 completed Stage 2 complaint forms were submitted generating 66 breaches of PDC standards. Whilst there has been an increase in the number of Stage 2 forms received there is a slight decrease in the level of breaches at Stage 2 compared to the same period in 2016. However there has been an increase in complaints escalated to Stage 3.

The complaints originated from 19 wholesale houses and News UK DTR. There were no complaints made against the NMA or PPA.

The majority of Stage 2 complaints were completed within the preferred 14-day timescale; however, 6 complaints were completed after the 28-day time limit.

During the period due unfortunately there were some delays with the adjudication of Stage 3 complaints. The situation has been addressed and the we anticipate all Stage 3's to be adjudicated within a 14-day period going forward.

This report will no longer update on the calls made to the PDF helpline as it is not strictly part of the complaints process. This data will be captured and reported into the PDC directly.

The next section of this report shows summary data for breaches by standard and association and timeliness. Detailed information by wholesale branch is included in the Appendix 1.
